### **4. Chairman's Report**

Moira Ellice (ME) read out her report.

ME summarised the activities over the past year. These included a number of very successful zoom meetings superbly organised by Jan Harris (this included the on-line members day), the continued success of the Facebook and Flickr groups run by Margaret Rainey and David Ryland respectively and the Portfolio group, run by David Harris. Jeremy Rodwell organised a field trip in Norfolk.

The 2020 Print Exhibition was displayed at The Apex in Bury St Edmunds for 2 months during the summer, and at the Edinburgh Photographic Society in November.

David Baxter organised an exhibition of 40 prints from the 2020 Exhibition, which are still in display at the Stamford Hospital.

ME detailed the changes being made to the Committee membership. Matthew Clarke stood down in December and ME, Gill Beckett, Bill Coles and Barry Freeman standing down at the AGM. ME thanked them all, along with the other Committee members and all the other volunteers for their support during her term in office.

ME gave special thanks to Barry Freeman for his work with the Group for the past 22 years.

ME also thanked Rebecca Johnson, Roger and Angela Ford, Mick Cant and Veronica Worrall for their support during the past year.

ME detailed the changes that had been introduced to the Exhibition procedures.

ME noted the line up of the new Committee.

ME thanked the membership for its continued loyalty to the Group and also thanked her husband, Neill, for all the support he had given her during her time as CEG Chair.

## **5. Finance Report and Accounts for the year ending 31st December 2021**

Nigel Rea (NR) summarised the finance report and went through the accounts as of the end of 2021.

NR talked about the continued use of Zoom and the cost this entails.

NR iterated that there had been a loss on income due to the scrapping of the entry fee for the Exhibition. This was partially offset by non-Group members paying to attend CEG Zoom events.

NR talked about the new accounting system introduced by the RPS and that the new system is much easier to work with.

NR mentioned the move to using a new printing company for the Creative Eye magazine, which incurred no additional cost. Increase in membership and higher postage rates have, however, resulted in an increase in the overall costs.

NR stated that there was an overall surplus of £2,301 giving the Group a reserve of £14,062.

Adoption of the accounts was proposed by Jan Harris and seconded by David Baxter.

SV stated that he will continue to set the Magazine, but the content would now be controlled by David Cooke.

Clive Watkins (CW) explained that during the year he had taken on this role and has been sending bulletins to the membership to increase awareness of the Group's activities.

CW published a long Newsletter before Christmas and intends a shorter update bulletin every month.

CW stated that he will be taking on the role of Membership Secretary as it aligns with his current tasks.

CW asked the membership to send him any suggestions they may have to help improve communications.

ME and GB thanked Clive for all he has done since taking on the role.
