Last week's highlights included some encouraging conversations with senior staff at the **arts councils** in England and Wales, sharing their views of the RPS, and its current and potential roles within the wider visual arts and participative arts sectors. I also met with **Gary Topp**, Director of the **Arnolfini** gallery here in Bristol, to talk about how we might work better together. I had a great conversation with **Helen Costello**, who runs the charity **Action for Children**, about an idea to create a new photography project for young carers; and I joined a meeting of the **Climate Change Working Group**, who have been doing so much to help the RPS address this most important of issues.

By the way, on **Friday** last week, I was filming for the BBC2 quiz "Only Connect" (for which I wrote the theme tune many years ago). It will be aired sometime after Christmas if you're curious to see me in a tux hitting lots of percussion instruments... !

This week, I had conversations with **Martin Baynes** (BIPP), **Caroline Kenyon** (Food Photographer of the Year) and **Robin Simpson** (Voluntary Arts). With great support from **Nikki, Michael, John** and the rest of the team, we concluded the budget for 2021, and I then sent out all my board papers (board meeting next Wednesday). I had a fascinating conversation with **Gary** this morning about the **Science Committee**; and with **Simon** we briefed an IT company about our **CRM** requirements. I've also been working with **Kate** to get an overview of the huge amount of activities taking place through our regions, groups and chapters. It's really incredible how much is going on, particularly as this activity is clearly providing photographic inspiration and support for large numbers of people who are isolated because of the pandemic. By the way, there are lots of really useful documents in our [volunteers area](#) (which Kate has been updating).

However, the **BIG** news this week (this year, even) was the launch of **The RPS Awards** on Wednesday. This is the culmination of a huge amount of creativity and hard work by many people, including the volunteers of the Awards Committee - and from the staff team: **Jo, Rebecca, Emily and Michael** in particular. You've all done such a wonderful job to assemble such a fantastic array of nominations and awards, across so many areas of photographic interest.
